Permission has been granted by the Barn Hunt Association, LLC for the holding of these barn hunt trials under BHA Rules and Regulations.

These trials OPEN to Berger Picards, Dutch Shepherds and Australian Cattle Dogs on August 2, 2019. Opens to all other breeds on August 16, 2019. Entries will be accepted on a First Received Basis. Dogs must be registered with Barn Hunt Association to compete. Register dogs at www.barnhunt.com Entries will be accepted as received until the limits are reached or until September 20, 2019. THERE WILL BE DAY OF SHOW AND LATE ENTRIES.

Classes offered: Instinct, Novice, Open, Senior, Master, Crazy 8 (limit 20). Including B classes. **There will be a short lunch break at the judges' discretion.** Trial 2 will follow Trial 1. **Crazy 8 will be between trial 1 and trial 2.** Moveups will be possible between each trial. Remember if your dog has passed Novice you can no longer enter Instinct.

Entry fees: \$18 for Instinct, \$20 for Novice, Open, Senior, Master and \$25 for Crazy 8's. Late and Day of show entries: \$ 20 for Instinct, \$25 for Novice, Open, Senior, Master, and \$30 for Crazy 8's.

Entry information: Dogs may enter both the Instinct Test and Novice class in the same trial *until the dog has earned the RATN title and then they cannot enter the Instinct Test.* All entries must be accompanied by entry fees to be valid. Feel free to use the BHA form that automatically populates your entry for you. This will ensure your forms accuracy as well as make it readable.

A returned check does not constitute a valid entry. There will be a \$50 fee for all returned checks. No entries will be taken over the phone. Make check payable to Ozarks Mischief Barn Hunt (or OMBH). Send entries & fees only to the trial secretary as entries sent to any address besides trial secretary will not be accepted.

No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee.

Refunds are available until the closing date of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded unless there is an available entry on the waiting list. Refunds are available for injured or deceased dogs. Notifications of injury or illness must be made to the trial chairman or trial secretary within 30 minutes of the start of the trial. A veterinarian note is required to be provided to the trial secretary within one week of the trials. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee.

Dogs must have a Barn Hunt registration number, entries will not be accepted if your dog is not registered.

EXHIBITOR INFORMATION

Please be aware of the rules for Barn Hunt trials. Rules may be found at www.barnhunt.com. All dogs must be on a short leash and under control while on trial grounds except while showing. **ELECTRONIC COLLARS, AND HEAD HALTERS ARE NOT PERMITTED** at the trial site. Please pick up after your dog and dispose of waste in appropriate containers.

Check in start: 8:00 AM
General Briefing start: 8:30 AM
Judges Briefing start: 8:45 AM
Judging start: 9:00 AM

RUNNING ORDER: Dogs will be run in staged groups of 5 with dogs being handled by the same person separated into different staged groups. Masters will be staged in groups of four. The exact run order will be determined after the trial closes.

CRATING: There will be crating space available but please make sure your crate is secure as the dogs may be highly excited. Crating space is first come, first served and will be limited. Crating in your vehicle is a possibility and might be encouraged depending on time of arrival.

Hotels/Motels that will accept dogs: Owners must assume full responsibility. Early reservations are recommended. As rules may change, please check with hotels before registering. BHA rules & common courtesy: you are responsible for picking up after your dogs at the motels & the show site.

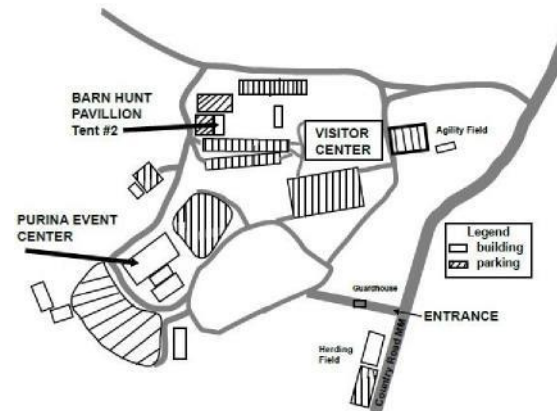
Crazy 8's: Limiting this class to the **first 20** dogs that sign up. First come, first served. It will be between the two trials. Come see and try this crazy game! We will have a Wait List for dogs who sign up after the first 20.

Awards: Ribbons will be awarded for 1st - 4th place in Novice, Open, Senior, and Master classes in each height division. Qualifying Ribbons will also be awarded to all qualifiers in the regular classes and Instinct Test. **High in Class Medals** will be offered in all levels. Title award Rosettes will be awarded to all dogs earning a new title. No unclaimed awards will be mailed. We will also have our "looser" baskets back by popular demand!

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial. Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

Dog Aggression: Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or trial committee.
